

# Terms and Conditions for Station Logix

## 1. Acceptance of Terms

By accessing or using the Station Logix application, you agree to be bound by these terms and conditions. If you do not agree to all of the terms and conditions, do not access or use the application.

## 2. License to Use

Subject to your compliance with these terms, Station Logix grants you a non-exclusive, non-transferable, revocable license to use the application solely for your fire station management activities. This license does not include any resale or commercial use of the application or its contents.

## 3. Account Registration and Security

You agree to (a) provide accurate, current, and complete information as may be prompted by any registration forms on the application; (b) maintain the security of your password and identification; (c) maintain and promptly update the registration data, and any other information you provide to the application, to keep it accurate, current and complete; and (d) accept all risks of unauthorized access to information and Registration Data.

## 4. User Responsibilities

You are responsible for all activities that occur under your account. You agree to use the application only for lawful purposes and in a way that does not infringe the rights of, restrict, or inhibit anyone else's use and enjoyment of the application.

## 5. Privacy Policy

Your privacy is important to us. The Station Logix Privacy Policy is hereby incorporated into these terms by reference. Please read the privacy policy carefully for information relating to our collection, use, and disclosure of your personal information.

## 6. Modification of Terms

Station Logix reserves the right, at its sole discretion, to modify or replace the terms at any time. If the alterations constitute a material change to the terms, Station Logix will notify you by posting an announcement on the application. What constitutes a "material change" will be determined at Station Logix's sole discretion, in good faith, and using common sense and reasonable judgment.

## 7. Intellectual Property

All content included on the application, such as text, graphics, logos, button icons, images, and software, is the property of Station Logix or its content suppliers and is protected by international copyright and intellectual property laws.

## 8. Termination

Station Logix may terminate your access to all or any part of the application at any time, with or without cause, with or without notice, effective immediately. If you wish to terminate this Agreement or your Station Logix account (if you have one), you may simply discontinue using the application.
